

# Woodhaven Business Improvement District (BID) MEMBERSHIP REGISTRATION FORM

The Woodhaven District Management Association, Inc. (the “BID”) includes properties along/from Dexter Court to 100th Street, as depicted in the map below. If you are a property owner, commercial tenant, or residential tenant within these boundaries (there are some exceptions – see the map and/or contact us for clarification), you may register as a member of the BID by providing the requested information below.



As a member, you will be expected to attend annual meetings and to cast your vote(s) at that time. You also have the option to appoint a proxy who would vote in your place. The proxy granted hereby is valid until revoked, subject to and in accordance with applicable law (for the avoidance of doubt, the proxy will be longer than the statutory default of 11 months, unless revoked earlier). There is no fee to register, and you will remain a member until your eligibility changes (e.g., there is a change in property ownership or tenancy). An individual or entity falling into none of the above three categories may still join as a non-voting member.
